1	Minutes of meeting of 1 st February 2010 The minutes were proposed by Calum Fraser and seconded by Andrew Leaver.	
2	 Matters arising from the minutes → Review of agreed actions from 11/01/10 15/3 – Douglas Graham has estimated between £6.5k and £7.1k for professional fees. As a charity we will be exempt from land stamp duty. It was agreed to confirm the fundraising target as £750,000 to allow for some start-up costs. 15/5 – We cannot claim Gift Aid until charitable status has been approved. Our application to OSCR has been lodged. 15/6 – requests for donations should make it clear that contributions are for the 'purchase and development of Aigas Forest' 15/12 – overtaken 16/1 – content of renewable energy consultation was agreed with Euan Fraser and the questionnaire has been circulated 16/3 – a letter has been sent to Sir John Lister-Kaye inviting him to be the Environmental Forest Champion
