	The Chair, Graeme Scott, welcomed the members of the public to the meeting and noted that although this was a Director's meeting with a published agenda, members of the public in attendance would be given full opportunity to comment on discussion.	
1	Minutes of meeting of 27 th September 2010	
	The minutes were proposed by Alisdair Stewart and seconded by John Graham.	
2	Matters arising from the minutes	
	\rightarrow Review of agreed actions from 27/09/10	
	 21/1 – John Graham attended the launch of Community Land Scotland at Eden Court on 28th September 2010. Aigas Community Forest was recognised as one of the 17 founder members of this organisation the aim of which is to give community land owners of all types a voice at the highest levels of government and policy making in Scotland. 	
	• 21/3 – John Graham and Alisdair Stewart attended the FCS Pine Tree Lappet Moth meeting on 5th October. In addition to hearing confirmation of previously received information about the moth, it was reported that should FCS require eradication the cost would be wholly met by the landowner or tenant at the time. This presents ACF with a significant potential for financial risk and will be taken into consideration when negotiating any transfer of control from FCS.

	The following two items were taken out of order.	
4	Update on Discussion with Falck Renewables	
	 Graeme Scott updated those present on contact to date with Falck Renewables: 	
	 Letter received from Falck dated 17/09/10 inviting discussion about allowing Falck access through Aigas Forest on the existing forest road for the purposes of developing a wind farm at Breakachy. 27/09/10 - Board authorised Graeme Scott and Andrew Leaver to meet with Falck to conduct 	
	 further discussion 22/10/10 – Graeme and Andrew met with Falck representative. This meeting was followed up with an e-mail from Falck. 	
	 Andrew Leaver sent a further e-mail and received a reply clarifying requirements to upgrade the road and likely volume of traffic. 	
	 Second letter received from Falck dated 27/11/10 providing further information on their activity and the current status of plans for Breakachy 	
	 Graeme Scott addressed those present clearly stating that the Board recognised that a significant element of the local community had concerns over the proposed wind farm. He assured those present that there would be a full discussion but also tabled a motion that the Board would not enter negotiations with Falck Renewables to allow access through Aigas Forest for the purposes of developing a wind farm at Breakachy. 	
	• This motion and the general issue of wind farm development were discussed, with several Board members and members of the public making clear their objection to the Breakachy development.	
	• A request was made to amend the motion to exclude discussions with any third party on allowing access for the purposes of a commercial wind farm. This was accepted.	
	• Steve Byford indicated that Kilmorack Community Council would be hosting a public meeting on wind farm developments including those at Breakachy and Druim Ba, once they had received sufficient information.	
	 The following motion was put to a vote of Board members and accepted unanimously: 'Aigas Community Forest will not enter into negotiations with Falck Renewables or any other party to allow access through Aigas Forest for the purposes of developing a commercial wind farm.'

3	 NFLS Guidance on Community Leasing of Forest Land The NFLS guidance on community leasing of forest land was published in early November. Graeme Scott noted that the guidelines for calculating rent were extremely complex and open to interpretation. Graeme had discussed these with Jon Hollingdale of the Community Woodlands Association who had prepared two models for illustrative purposes, based on different interpretations of the document. These produced annual rentals of £50,000 and £7,000 respectively, thus illustrating the vague nature of the guidelines. Any rental would ultimately be set by the District Valuer and ACF could be the first community group to test the guidelines. Graeme stated that further work would be necessary to improve and test the existing forest projections and to explore whether it would be possible to justify or negotiate a 'viable rental' within the guidelines. Andrew Leaver noted that should a request from ACF for a transfer to community rental be accepted by the NFLS then a further 18 months would be available to finalise a lease agreement. This request can be sent at any time up to June 2011. During this period of approx. 18 – 24 months it would be acceptable for ACF to continue to fundraise for outright purchase. The current purchase price of £690,000 would lapse and a new value be set if ACF were to then request purchase. Given the financial risk presented by the Pine Tree Lappet Moth this may work to the advantage of ACF. It was agreed to seek permission from LEADER to use existing grants to contract with a forestry specialist to undertake detailed examination of the lease option and to support completion of the business plan. If LEADER approve use of funds, a tendering process to appoint a specialist consultant will be undertaken before any lease is signed. 	Andrew Leaver Andrew Leaver
