	<ul> <li>Andrew Leaver confirmed receipt of a letter from Bob McIntosh, Director, FCS extending the NFLS approval period until 30 June 2013.</li> </ul>	
5	Scottish Land Fund	
	• For some weeks contacts at HIE had been suggesting that the Scottish Land Fund may have to apply EU State Aid rules to any grant for the purchase of forestry by a community group.

	<ul> <li>The result is that an application to the SLF could only request a maximum of 20% of the purchase price, potentially £150k - £170k depending on valuation. This would leave in the region of £550k+ to find.</li> </ul>

6 L • •	<ul> <li>easing Option</li> <li>FCS has issued new guidance on leasing by community groups.</li> <li>Andrew Leaver and Lorna Campbell met with Bob Frost and Malcolm Wield from FCS on 30<sup>th</sup> November.</li> <li>At its simplest level the new lease methodology is an improvement with a base rent for the land and a 'cut' of profit on timber sales as they take place.</li> <li>In order to identify potential land rent values and also to forecast timber income it was proposed to work with Jon Hollingdale at Community Woodlands Association and to contract the District Valuer to provide some rent values based on the FCS methodology. Funding is available within the current support package from HIE / FCS / Council. It was agreed to take this approach.
